



BOB FM Road Trip #100: Bon Jovi in Montreal

OFFICIAL RULES AND REGULATIONS

1. TO ENTER the **BOB FM Road Trip #100: Bon Jovi in Montreal** contest simply visit our web site at www.bob.fm, click on the Contest page and open the 100 Ways to Qualify for BOB FM Road Trip #100 Document and review the 100 ways to qualify. Contestants qualify by using the procedures listed in the 100 Ways to Qualify for BOB FM Road Trip #100 document. Contestants may use each qualifying procedure only once, but may use multiple procedures to qualify for this contest. If, while qualifying for BOB FM Road Trip #100: Bon Jovi in Montreal, a contestant is found to have broken the law while completing a procedure all of those contestants' entries will be made void. In the event of a dispute, entries received on-line shall be deemed to be submitted by the "Authorized Account Holder" of the email address submitted at the time of entry. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an internet access provider, on-line service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries must include your first and last name, mailing address, email address, age, ten digit daytime and evening telephone number. Limit of one (1) entry per qualifications procedure per individual. If it is discovered that you attempted to enter using the same qualification procedure more than once, all your entries will be void. For mail in entries, each entry must be sent separately and must bear sufficient pre-paid postage. Entries will be rejected if entry form is not fully completed and received during the Contest Period. Illegible entries, bulk drop-offs, or mechanical reproductions are ineligible. Contest starts on **Monday, March 1st** and closes on Thursday, March 11th with the Grand Prize Draw taking place on Friday, March 12th at 8:10am. There is one (1) Grand Prize consisting of 2 tickets to Bon Jovi at the Bell Centre in Montreal on March 19th, transportation for 2 and overnight accommodations (**the "Prize"**) to be won from among all the eligible entries received during the Contest Period. No purchase necessary. Void where prohibited.

2. The contest sponsors are **103.7 BOB FM** a division of CTV Limited (hereinafter referred to as the "Contest Sponsors").

3. To enter and to be eligible to win, entrant must be a legal resident of Ontario, reside within the '613' Area Code, and be **eighteen (18) years of age or older**. Employees and their parents, siblings and children, and persons domiciled with an employee of any of the Contest Sponsors, their agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, and promotional and advertising agencies and administrators, are ineligible to enter. A winner of a **103.7 BOB FM** Radio contest in the 30 days preceding the start of this Contest are not eligible to enter.

4. Prize - There is **one (1) Prize** consisting of **2 tickets to Bon Jovi at the Bell Centre in Montreal, with transportation and overnight accommodations (subject to availability)**. Trip includes: round trip economy airfare for two (2) from a Brockville or Kingston train station, one (1) night accommodation (based on one room, double occupancy) as chosen by the Contest Sponsor(s), subject to availability. Grand Prize winner and his/her travelling companion(s) are solely responsible for all costs not expressly described herein including, without limitation, applicable taxes, fuel/currency surcharges, ground transportation, meals, beverages, room service, gratuities, merchandise, telephone calls, insurance together with any required travel documentation, and all personal expenses of any kind or nature, together with any applicable overnight layover. Flight dates and hotel accommodation are subject to change without notice or compensation. Grand Prize winner and his/her travelling companion(s) are also solely responsible for all costs incurred to and from the Departure Point as the Grand Prize originates and terminates

there. It is the sole responsibility of the Grand Prize winner and his/her travelling companion(s) to obtain all necessary travel documentation including passports and visas if applicable and to comply with any customs and immigration requirements. Grand Prize winner and his/her travelling companion(s) must be able to travel at the times and dates as determined by the Contest Sponsor(s) in its/their sole discretion failing which the Grand Prize will be forfeited. It is recommended that Grand Prize winner and his/her travelling companion(s) obtain sufficient personal insurance prior to departure.

5. Prize must be accepted as awarded. The Prize may not be sold, transferred and is not convertible to cash. Contest Sponsors reserve the right to substitute the Prize in whole or in part in the event that all or any component of the Prize is unavailable. Prize winner is solely responsible for all costs not expressly described herein.

On **March 12th at 8:10am**, a random draw for the Prize will take place at **103.7 BOB FM in Brockville, ON** by the hosts of the **103.7 BOB FM morning show known as BOB's Breakfast**, from among all eligible entries received during the Contest Period. The first entry drawn will be eligible to win the Prize. The odds of winning the Prize will depend upon the total number of eligible entries received during the Contest Period. The on-air announcer of 103.7 BOB FM acting reasonably, will announce the name of the potential winner on-air immediately following the draw at 8:10am. The potential winner will then have 10 minutes and 37 seconds to contact the hosts of BOB's Breakfast by telephone at 1-800-495-1037. In the event the potential winner does not contact the morning show within the allotted time he or she will be disqualified and an alternate potential winner will be drawn. Further, if there is not a clear telephone connection between **103.7 BOB FM** on-air announcer and the potential prize winner, such that one or each other cannot hear the other, such potential prize winner is disqualified, and the Contest Sponsors will not be liable in any way for such failed connection. In conducting the contest, **103.7 BOB FM** on-air announcer has the full and absolute discretion to disqualify any potential prize winner who fails to respond on the phone or whose response cannot be heard by such **103.7 BOB FM** representative, and the Contest Sponsors shall have no liability or responsibility to any caller so disqualified. Proof of identification must be provided upon request. In order to be declared a winner, potential winner must first correctly answer, unaided, a time limited mathematical skill testing question administered by CTV Limited **103.7 BOB FM**. Before being awarded a Prize, potential winner, and his or her travelling companion, as applicable, will be required to sign and return within the time stipulated by the Contest Sponsors, a full release and indemnity form stating that he/she has read and understood these official rules and regulations ("Rules"), grants all consents required, authorizes the Contest Sponsors to broadcast, publish and disseminate his/her name, city of residence, photograph, likeness, sobriquet and voice, in connection with any promotion or publicity, and/or for general news, entertainment and information purposes at no additional compensation to the potential winner, beyond the awarding of or participation in the Prize, accepts the Prize as offered and releases the Contest Sponsors from any and all liability of any kind arising out of the potential winner's participation in this Contest and receipt and use of the Prize. In the event that the potential winner does not comply with all the provisions as contemplated in these Rules, Contest Sponsors shall have the right to disqualify potential winner, and draw an alternate potential winner and the Contest Sponsors shall be fully and completely released and discharged from any liability or responsibility in this regard. The provisions and procedures referred to above relating to selection and notification of a potential winner, if applicable, shall be applied, with the necessary amendments, until a qualified winner has been duly selected.

7. By entering this Contest the entrants and participants automatically agree to accept and abide by these Rules. All decisions of the Contest Sponsors with respect to any aspect of this Contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Contest.

All entries become property of Contest Sponsors who assume no responsibility for garbled, lost, late, delayed, destroyed or misdirected mail, voice messages, e-mail or any computer errors or malfunctions. No correspondence will be entered into except with entrants requesting Rules by mail or requesting names of prize winner (for which a self-addressed, postage paid envelope must

be included). Contest Sponsors do not assume any responsibility for incorrect or inaccurate capture of entry information, technical malfunctions, human or technical error, seeding or printing errors, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software or any combination thereof. Entry materials-data that have been tampered with or altered are void. If for any reason, in the opinion of the Contest Sponsors, in their sole discretion, the Contest is not capable of running as originally planned, or if the administration, security, fairness, integrity or the proper conduct of the Contest is corrupted or adversely affected, including by reason of tampering, unauthorized intervention, fraud, technical failures or any other causes beyond their control, Contest Sponsors reserve their right to cancel, terminate, modify, amend, extend or suspend the Contest and select a winner from previously received eligible entries. Contest Sponsors reserve their right to modify the Rules without materially affecting the terms and conditions hereof. The Contest Sponsors reserve their right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Rules or otherwise in a disruptive manner. Any attempts to deliberately damage the Contest web site or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made the Contest Sponsors reserve their right to seek remedies and damages to the fullest extent of the law. Contest Sponsors shall not be held responsible for any errors or negligence that may arise or occur in connection with the Contest including any damage to an entrant's computer equipment, system, software or any combination thereof, from downloading any material from the Contest web site, where applicable.
